



NEBRASKA STATE FIRE MARSHAL FIREWORKS LICENSE APPLICATION 2012 SELLING SEASON

- Please read all instructions carefully. Applications **MUST** be filled out **COMPLETELY**. Incomplete applications will be declined and returned to the applicant, which may result in missed deadlines. Each stand requires a separate application. **PAPER APPLICATIONS:** we will accept check or money order for payment; applications must be submitted by mail or in person. (E-mails and faxes are **NOT** accepted).
- Retail applications for the **July 2012 selling season** must be received by the State Fire Marshal's Office **no later than 5:00 PM on June 12, 2012. Applications received after this date will not be accepted.** Applications accepted beginning **January 1, 2012.**
- Retail applications for the **December 2012 selling season** must be received by the State Fire Marshal's Office **no later than 5:00 PM on December 8, 2012. Applications received after this date will not be accepted.** Applications accepted beginning **January 1, 2012.**
- **ANY** changes **MUST** be submitted on the Fireworks License Application Change Form, available on our website. Only one location change is permitted within the same city. Additional location changes shall require a new application and fee.
- Applications are subject to all provisions of State Statutes and regulations governing fireworks, e.g. NFPA 1124. It is the applicant's responsibility to read and comply with these requirements. These requirements are subject to change without notice.

Type or PRINT LEGIBLY. APPLICATIONS MAY TAKE UP TO 14 BUSINESS DAYS TO PROCESS.
